Also the use of block form quotations is out of format, and used many times instead of regular quotations. Several endnotes and pages numbers seems to be missing.

Final Comments & Questions

The thesis is short and does not meet the page requirement. There are problems with proportion and control over the information being reported. I have mentioned above many formal elements which are distracting, the worst being quotations as they cause confusion where the author's ideas begin and end verses her sources. Also, I am really shocked that the author did not bother to discuss the climax of *Tess of the D'Urbervilles* which takes place at Stonehenge. Certainly this pre-Christian, pagan monument must be significant to the question of nature verses culture in Hardy's work.
