1. Spatial Data Interest Community (SDIC)

Spatial Data Interest Communities (SDICs) bundle the human expertise of users, producers and transformers of spatial information, technical competence, financial resources and policies, with an interest to better use these resources for spatial data management and the development and operation of spatial information services. Through their activities they drive the demand for spatial data and spatial information services. Environmental monitoring, reporting and development of applications and services for environmental management are among the main driving forces behind the natural formation of SDICs. SDICs are best placed to know what spatial data is required in implementing different environmental tasks, ranging from local, regional, and national to Pan-European applications.

The involvement of SDICs can be one or more of the following:

- be kept informed about the INSPIRE activities
- review INSPIRE deliverables
- propose experts to participate in Drafting Teams working on the preparation of the detailed implementing rules of INSPIRE
- propose reference material for INSPIRE Implementing Rules development.
- propose pilot projects to feed or test INSPIRE Implementing Rules
- provide comments to draft Implementing Rules
- test draft specifications.

Registration is continuously open.
