In general, the results are presented very systematically and the commentary is clearly differentiated However, it is not clear what the commentary on classroom research is based on as there are no results presented. Were any data collected during the experiment?	The Method Chapter gives a clear picture of where and how the research was carried out and who the subjects were. I only wonder why the detailed lesson plan (with specific goals of each stage) is not provided in the appendices.	The author reviews a range of ideas associated with fairy tales. In general, they provide an acceptable theoretical framework for her future research. However, the balance of all included information can be in question in relation to the experiment carried out. It seems that the general theoretical literature information (e.g. the history of fairy tales on pp. 5-7, biographies about fairy tales collectors on pp. 8-10, or detailed descriptions of classification of fairy tales in English tanguage Teaching (one and a half pages). Moreover, nothing is written about the role of fairy tales in lower secondary school pupils.	Comments The Introductory Chapter sets the research goals and contains a chapter by chapter outline.
