Final Comments & Questions

This is a problematic thesis to say the least. There is very little critical perspective brought to the thesis despite the supervisor's continued emphasis on this point:

On June 9, the supervisor wrote to the author:

The small mistakes must be fixed. Close the spaces between paragraphs. You must run English language spell check on the document and get rid of any sentence fragments. Under Economics of North and South: "The essentials of battle," is not a sentence and this is the kind of writing that will get you blocked at the defenses. Much of the writing could be improved and I don't know if you can find someone to help you more than I can right now. I have already mentioned you need page numbers for your references. You need a clear thesis statement at the end of your introduction. Right now you are only telling the reader what he already knows, The Civil War was important. You will have to craft an argument that intertwines the relationship of economics to war in order to thematically unify the thesis. The battle section is still a list of events and to whatever extent possible you are going to have to bring economics as part of the conversation and make this part more argumentative. Can you send me the conclusion and references page soon.

I find that the author did greatly improve the micro elements of the work, but was ultimately unwilling or unable to crack the macro structure and improve the argumentative and critical requirements of the thesis. This is not to say there still aren't many problems in relation to syntax and style, but still it is worth noting improvement was made from the earlier draft. To some small extent improvement was made concerning the discussion of the economic and political elements leading up to the Civil War, but this was not extended to the actual events of the Civil War. Sadly, it would have been rather easy to have revised the introduction and conclusion to reflect these more argumentative elements and that would have greatly improved the readers impression of the thesis overall.
