Final Comments & Questions

Even a cursory glance at the sports section of any national daily newspaper will show the enormous amount of attention devoted to football in England and thus, by implication, its importance to a substantial section of the general population. This thesis focuses on the cultural significance of football to English people with specific reference to the English Premier League (EPL).

The author begins by offering a brief historical overview of football in England, from its working class roots back in the 19th century, through most of the 20th century, during which football clubs still maintained relatively close links to the communities in which they were based and players would frequently travel to home matches on the same municipal buses as their fans, through to the modern era of the EPL and the wholesale transformation of the game into a multi-million pound industry dominated to a large – some would say unhealthy – extent by professional business interests rather than local allegiances and pride.

Yet still the fans' passion remains, amply reflected in the response to Mr Živčák's online questionnaire. At this juncture, one should beware of lapsing into the occasionally hyperbolic language of English TV football pundits, so let us just say that, for the supervisor of the thesis, a total of 666 responses in less than 24 hours was a pleasant surprise and somewhat surpassed expectations. True, after filtering out the non-English participants, that number was reduced to 426 but even then it is a considerably higher total than would normally be found in a bachelor thesis survey. The author subsequently makes an excellent job of analysing the acquired data and selecting relevant quotations to enrich his main text.

The work as a whole is logically organised and excellently written in a style which holds the reader's interest throughout. It covers a wide range of topical issues, any of which would be worthy of deeper analysis. One with which the writer of this report can associate is preferring club over country, which, in a sense, raises the issue of whether there is any such thing as a genuine English identity at all. Another interesting point is that while a majority of supporters agree that a cap on the number of overseas players eligible to start an EPL game might benefit the national team, not all of them would favour such a move because it would most likely have a detrimental effect on the performance of their favourite club. From this it would appear that the oft-described animosity displayed by the English towards foreigners, especially since the ill-fated decision to leave the EU, does not extend to superstar footballers. It would be interesting to know how many of the diehard fans who regularly attend their chosen EPL team's games voted for Brexit; that, however, is a thesis topic for another day.
