Final Comments & Questions

The undergraduate thesis deals with a topic within the area of lexicon, focusing on the issue of borrowed words. Since English is usually viewed as a language from which words are taken and further spread to other languages, this work suggests a bit different point of view because it deals with the very opposite – with loanwords in English.

The work is divided into individual chapters, starting with the Introduction, where the author provides a description of her work. The next chapter presents the information about the process of borrowing, explains the term "calques" and relates it to the term "loanwords". Further she distinguishes between necessary borrowing and unnecessary borrowing and focuses on recognizing borrowed words.

In the following chapter the author takes into consideration a historical point of view in order to describe the process of borrowing in English at individual levels of the development of the language. All this is very crucial for the subsequent analysis of a wide variety of texts of various styles.

The analysis is detailed, careful and makes it possible for the author to summarize the results and, in the last chapter of the work to draw relevant conclusions.

The contents of individual chapters in the Theoretical part of the work as well as the results of the analysis and the conclusions drawn from the results, proves the author's ability to work with technical literature, find relevant information, collect data and process them in adequate way. The language is at a good level, the lay-out of the work is excellent.

To sum up, the above assessed undergraduate thesis can be considered an excellent piece of academic writing.
